

## Privacy Policy for Speedax Global Systems Limited

Speedax Global Systems Limited is committed to protecting the privacy and confidentiality of personal

data as well as ensuring the safety and security of information collected or processed during its

operations and engagements. This Privacy Policy outlines the principles that govern how we collect,

use, retain, and protect personal information in connection with our products and services.

### Scope

This Policy explains how we process personal data, how it is used to deliver services, and with whom it

may be shared. It applies to customers, clients, partners, employees, contractors, vendors, and any

third parties who interact with or process personal data on behalf of Speedax Global Systems Limited.

### Personal Data We Collect

- Contact information: Name, email address, phone number
- Identification information: Government-issued identity documents, passport details
- Financial information: Bank account details, transaction history
- Data collected automatically: IP address, device details, browser data, location
- Data collected manually: Age, date of birth, gender, physical address

### Use of Personal Information

We use personal data to:

- Deliver and improve our products or services
- Communicate with individuals about services, accounts, or support
- Conduct analytics and internal business research
- Manage employee or contractor relationships
- Comply with legal or regulatory obligations
- Protect the rights, property, and security of the Company and its users

### Use of TrueDepth Camera, ARKit & Device Features

Our application uses Apple's TrueDepth APIs and ARKit technology strictly for identity verification, liveness detection, and regulatory compliance. We do not collect, store, share, or transfer any TrueDepth or face-mapping data.

#### TrueDepth Camera & Facial Data Processing:

- TrueDepth provides depth, facial movement, and mapping data ONLY to confirm liveness.
- Processing occurs 100% on-device in real time.
- We do NOT store, transmit, upload, or retain any TrueDepth information.
- We do NOT use facial data for identification, profiling, advertising, analytics, or tracking.
- TrueDepth sessions activate only during verification and terminate immediately afterward.

#### ARKit for Liveness Detection:

- Used to detect depth, motion, and natural facial responses.
- No 3D face mesh, depth map, or orientation data is ever stored or shared.

#### Background Location:

- Used once for Tier verification to confirm regional eligibility.
- Not stored, transmitted, or retained.

All permissions are requested using Apple's native system prompts and require explicit user consent.

#### Data Retention

Personal data is retained only as long as necessary for service provision or legal compliance. When no

longer needed, it is securely deleted or anonymized unless retention is legally required.

#### Data Security and Protection

We implement robust administrative, technical, and organizational measures to safeguard personal data

from unauthorized access, disclosure, alteration, or destruction.
